The Ohio Economic Development Institute (OEDI) is a unique continuing education program designed to meet the specific needs of Ohio's intermediate and advanced economic development professionals. Developed in partnership with JobsOhio and Ohio University Voinovich School of Leadership and Public Affairs, OEDI offers high quality, state-specific continuing education opportunities.

The curriculum is designed to prepare professionals and the organizations they serve to be successful and win in the highly competitive state and global economic environment and serves as the pathway for achieving the Ohio CED) credential.

Prerequisites: There is a prerequisite for all Institute courses. Attendees must have completed The Ohio Basic Economic Development Course or have three years of economic or community development experience. Individuals who will be taking the Ohio Basic Economic Development Course in April 2017 may register for the courses.

The first series of courses will be offered at Ohio University's state-of-the-art Dublin campus. The cost for each of the two-day core courses is \$499 for Ohio Economic Development Association Members and \$599 for non-members. Special multiple course pricing will offer a savings of \$50 per course when you register for two or more courses in 2017.

Course Descriptions:

Real Estate: This course is designed to provide the economic development professional with the critical steps of real estate development and a comprehensive understanding of how a deal progresses through to completion. Attendees will analyze the anatomy of a real estate deal and learn how each component stage impacts the next, and how real estate development is practiced in Ohio. This understanding will help the ED professional recognize the challenges (and often barriers) to advancing a new development in their community and to more thoughtfully understand approaches in helping close the deal.

Finance/Incentives: This course is designed to provide economic development professionals with a strong understanding of the finance and incentive programs that are available and utilized in Ohio. Through interactive case studies, discussions, and speakers, the course will also give students the opportunity to work through real-world examples of how incentives are utilized. This will include both program details and how the programs are utilized in practice. The course will cover how the private capital markets work, public sector financing programs (such as JobsOhio, SBA, USDA, New Markets Tax Credits, etc.) along with incentives such as property and income tax credits, tax abatements, and grants at both the state and federal levels.

Retention and Expansion: This course will focus on both the program and practice of working with existing companies in Ohio, developing longstanding professional relationships, understanding company risks and opportunities, connecting companies to vital resources, and coordinating with JobsOhio and the JobsOhio Network for company

visits. The course will also cover establishing and managing an effective retention and expansion in a community, aligning with JobsOhio sector team efforts, and collaborating with nearby communities.

Site Selection / Site Development: This course will focus on site development and the site selection process. The site development aspects of the course will focus on the process of how to make sure that that Ohio communities have shovel-ready sites that are competitive, including working with engineers, utilities, engineers, land planners. The site selection part will provide the economic development practitioner with the basics of the JobsOhio site selection program, participation in the SiteOhio site certification program, working with site selectors, making sure that their community can be competitive, and the negotiation process.

International Market Access Grant for Exporters (IMAGE)

The Ohio IMAGE Grant, funded by the State of Ohio and the U.S. Small Business Administration (SBA), is designed to increase exports and create jobs. The IMAGE grant offers financial assistance for small businesses to promote their products and services in international markets. USDA Rural Development Business & Cooperative Programs

Rural Development is pleased to announce important changes to the Business & Industry (B&I) Loan Guarantee Program. These changes will better serve rural communities by helping lenders provide loans to businesses and helping to increase employment opportunities for rural residents. These changes include but are not limited to:

- Removal of the U.S. Citizenship requirement for companies wanting to use the B&I loan guarantee to increase employment in rural areas. The applicant company will need to demonstrate the loan funds will remain in the United States and will be invested in the rural community to create and retain employment opportunities.
- Owner subordinated debt may be included as equity provided the debt was established in exchange for cash and the debt remains in the company for the life of the guaranteed loan. This change can help applicants meet the minimum tangible balance sheet equity requirements of the program. Minimum tangible balance sheet equity for an existing business is 10% while a startup business is 20%. All financial statements must be prepared according to Generally Accepted Accounting Principles.
- New Market Tax Credit projects are now be eligible for assistance through the B&I program. Subordinated debt made by the Community Development Entity can be considered as equity into a project. This is another means of helping the business meet the minimum tangible balance sheet equity requirements.
- The guarantee fee can be reduced to 1% of the guaranteed portion for businesses that support value added agriculture; promotes access to healthy foods; or is a high impact business development investment.
- Loan guarantees can for agricultural production can be 50% or \$5MM, whichever is less, of vertically integrated businesses. This is a substantial increase from the previous agricultural production maximum amount of \$1,000,000.
