## What is the Summer YouthWorks Program?

The program provides job readiness skills training and summer employment for eligible youth in Montgomery County. Students will work at various businesses which will help build your resume, develop independence and expose you to the business community and mentors.

### **Eligibility Requirements**

Participants must be full-time students, 14 to 18 years old and live in Montgomery County. Eligibility is based on household monthly income and size.



Since our founding in 1911, DP&L has been a proud partner with Dayton and our surrounding communities. One of our goals is to protect the environment by supporting organizations that conserve or improve the natural world around us. To meet that goal, DP&L is offering the opportunity for communities in our service territory to enrich their cities or parks with an Environmental Grant as part of our Right Tree, Right Place program.

In 2016, DP&L awarded \$50,000 grants to the cities of Centerville and Sidney for Right Tree, Right Place investments.

#### **About Right Tree, Right Place**



Trees are an important part of the environment which beautify our neighborhoods and communities. The type of trees and their placement along with other vegetation could impact the safety and reliability of electric services to our customers. Designed with our customers in mind, Right Tree, Right Place encourages customers to plant smart with utilities in mind. <u>Learn more</u>.

**2017 Environmental Grants** 

To apply for the DP&L Environmental Grant, applicants must be communities that have the <u>Tree</u>

City USA designation from the Arbor Day Foundation. Two grants will be awarded in 2017;

each grant will have a maximum value of \$50,000. The 2017 grant application deadline has

been extended to March 17, 2017. Winners will be announced on Arbor Day - Friday, April 28,

2017.

**Grant Requirements** 

Projects for the grants should be aimed at improving a city's business district or park(s).

To qualify the project must utilize 40% of the grant funds on trees, other vegetation or

environmental improvements.

The project may include the installation of other amenities such as lighting, park benches,

walkways, playground equipment, outdoor art, fountains and similar hardscapes.

**How to Apply** 

All applications must be submitted online using our Community Relations Form. To ensure your

application is designated for the Right Tree, Right Place environmental grant, please follow these

instructions:

Under "Basic Information":

• Application for: **DP&L Contribution** 

• Type of Request: **Program** 

• Timeframe: Single Year

• Funding Area of Focus: **Environment** 

In the "Short description of the program/project field," please begin with the label "Right

Tree, Right Place," followed by a full description of the project.

Please note, some of the questions on the form are geared at traditional non-profit grants; the

applicants should respond with appropriate information or type "RTRP" in the field.

We look forward to seeing your project ideas and supporting our communities' efforts to improve the environment.
