



### Troy medical office building sold

- Upper Valley Medical Center, affiliated with Premier Health, purchased the Upper Valley Medical Park at 3006 N. County Road 25A for \$2.3 million.
- The 33,000-square-foot building was built in two phases between 2005 and 2008 and sits less than a mile away from the Upper Valley Medical Center.
- Plans are to use the building for doctors' offices and additional medical office space.
