## BizCap Can Now Provide Rural SBA Loans in Six States!

If you are looking at your next expansion project or investment in a rural county and are you having a problem finding financing for your growing business? Since 2013, small businesses in many rural counties have found that accessing SBA 504 loans has become difficult because a significant number of rural Certified Development Companies (CDCs) are no longer in business. The end result is that affected rural small businesses are struggling to find the financing that they need to buy new real estate and machinery needed to keep their companies growing.

So, what can rural small business owners do when they need to finance their company's growth? BizCap clients can benefit from a new two year pilot program from the SBA. The program allows CDCs like BizCap to issue SBA 504 loans in rural counties in any state that is within their SBA region (BizCap is in Region 5). Region 5 includes Illinois, Indiana, Michigan, Minnesota, Ohio, and Wisconsin. To simplify maters, the program applies in any county that has been classified as "mostly rural" or "completely rural" by the US Census Bureau. Don't know if your business is located in a rural county? Call us and we'll let you know.

## Not familiar with the SBA 504 loan program?

504 funds can be used to finance the purchase or construction of owner occupied commercial property or the purchase of equipment. Benefits of the program include fixing the interest rate for the term of the loan at below industry rates. Real estate rates are fixed for 10, 20, or 25 years. Equipment rates are fixed for 10 years. In the typical SBA 504 loan structure, the third party lender, bank or credit union, finances 50% of the project, SBA finances 40%, and the borrower injects 10%. This allows the borrower to retain more of their operating cash.



## Welder Qualification versus Welder Certification -Understanding the Difference



When a student attends one of our two programs here at HIWT, they have the opportunity to earn four or five (depending on the program) AWS® QC7 Certifications. Many people confuse the terms "certification and qualification". So, what actually is the difference between a welder qualification and a welder certification?

In general, the term "certified" is misused. When an employer is looking for "certified" welders what they are actually looking for or referring to is a QUALIFIED welder. When a company sends an employee to HIWT for testing or if we send someone to a company to witness testing (i.e. when one of our CWI's goes to the company's place of business) the employee/welder will take a weld test. That test is called a Welder Qualification. When the welder successfully passes the test, people generally say they are "certified". This is not true, they are actually "gualified" to weld a certain process/electrodes/positions/material; all determined by the WPS (welding procedure specification) their company had them test to. It is important to know that you do not have to be an Accredited Testing Facility to administer these tests. When a welder takes a welder qualification test, it pertains to their job and the needs of the company they currently work for. When they leave the company, none of the so called "certifications" go with them. That is because they were never certifications. They were qualifications.

The American Welding Society started a program for Certified Welders (CW) years ago. In order to test welders and certify them in accordance with OC7-93 you must comply with the AWS® OC4-89 Standard for Accreditation of Test Facilities for AWS® Certified Welder Program. So HIWT had to become an Accredited Testing Facility to offer QC-7 Certifications. The purpose of this was to provide a way to actually certify welders to various processes for various industries. There is a major difference here. Instead of testing an employee for a company, now we are testing a person and certifying that they properly followed welding procedures and their tests meet the quality standards set by the American Welding Society. A buzz word around HIWT is obviously the QC-7 cert tests. This is the QC7-93. There are three supplements to QC7-93 each for a particular industry. The first is QC7-93 Supplement C for Sheet Metal Welding code, next would be Supplement F for Chemical Plants and Refinery Piping, and lastly is Supplement G. Supplement G is the AWS® Welder Performance Qualification Testing. This Supplement is used by the school for our QC-7 testing. It offers the widest array, and is the best choice for us because we do not know which industry each of our grads will end up working for. Once a student successfully passes a OC-7 test, they are in fact, certified. They will be issued a wallet card, and will be listed on the national registry:

The cert(s) obtained while at HIWT do travel with the student and they can be utilized as long as they renew them every 6 months.

In short, if a person does not have QC-7 certification they are not certified. They may be qualified to weld various welding procedures for a company, but as a far as AWS® is concerned, they are not a Certified Welder unless they possess QC-7 certification(s)

HIWT is an Accredited Testing Facility for the American Welding Society. All of our students are tested and certified on site. Paperwork is then sent to AWS® where it is processed and the student is sent their certification card. 

August 13, 2018

#### Sherwood Shopping Center in Troy sold

- The shopping center at 914 N. Market Street was sold to Sherwood of Troy LLC for \$1.7 million.
- The 80,000-square-foot shopping center was built in 1957 and has become largely vacant in recent years.
- Redevelopment scenarios include adding new tenants, "frontage development", and retaining and reinvesting in Needler's Fresh Market, one of the center's anchor tenants.
